## A. Possible Corrective/Negative Feedback Sequence with Modified Output (recast):

1. elicit or input (inaccurate) example, e.g. *Caesar Brutum mittit ut [pacem petit]*.
2. (teacher) offer corrective feedback as recast, e.g. *ut pacem [petat]*
3. (student) offer corrected output *Caesar Brutum mittit ut pacem petat*.
4. (student) generate partial modified output using a variable lexis of verbs only: e.g. *ut pacem [perdat]*; e.g. *ut pacem [servet]*; e.g. *ut pacem [cohipeat]*; or generate partial modified output with variable lexis of the whole clause: e.g. *libellos legat, det, obtineat*.
5. (teacher) offer corrective feedback to elicit correct utterance as needed.
6. elicit or input (inaccurate) example using new tense, e.g. *Caesar Brutum misit ut [pacem petat]*.  
*iterum*

## B. Dati Rewrites at Word Level

- (word order) *Marcus Cicero utitur familiariter Publio Lentulo ⇒ Publio Lentulo Marcus Cicero familiariter utitur* [A2r]
- (gerunds vs. gerundives) *gratia gerendi bella ⇒ gerendorum bellorum gratia* [A4r]
- (supines to gerunds) *iucunda auditu ⇒ iucunda ad audiendum*
- (superlatives for adverb+adjective) *maxime memorabile facinus ⇒ memorabilissimum facinus*

## C. Dati Rewrites at Phrase Level

- (double dative) *tuae mihi litterae fuerunt gaudio = tuae litterae mihi gaudium attulerunt* [A6r]
- (phrases replaced with synonymous structures) *afficio te honore = te honoro = tibi facio honorem* [A6v]
- (partitive) not *multam virtutem* but *multum virtutis* [B1r]
- (adjectival) *Laelius habet faciles mores = Laelius est leni ingenio natus = Laelius est facili natus ingenio = Laelius est facillimus moribus*

## F. Select Glossary (adapted from various sources)

**Attention:** The aspect of the cognitive system underlying language processing responsible for the selectivity of processing goals.

**Corrective Feedback:** Information provided to learners about the ill-formedness of their L2 production.

**Focus-on-form:** The allocation of focal attention to language form during an otherwise meaning-focused interaction.

**Form-Focused Instruction:** Any planned or incidental instructional activity that is intended to induce language learners to pay attention to linguistic form.

**Input processing:** Making a connection between form and meaning/function during comprehension.

**Interaction approaches:** Approaches that consider conversational interaction as a locus of learning.

**Interface position (noninterface):** There is no connection between implicit and explicit knowledge; explicit knowledge cannot turn into implicit knowledge.

**Interface position (strong):** Explicit knowledge resulting from instruction can become implicit knowledge through practice.

**Interface position (weak):** Explicit knowledge facilitates the development of implicit knowledge through promoting other processes (e.g. noticing) that aid acquisition.

**Knowledge, declarative:** Knowledge of facts (semantic memory) and events (episodic memory); sometimes called knowledge THAT as opposed to knowledge HOW.

**Knowledge, procedural:** Knowledge that can only be performed, such as how to swim or speak fluently; sometimes called knowledge HOW as opposed to knowledge THAT.

**Modified output/recast:** The learner's reproduction of rephrased or reformulated original utterances.

**Noticing:** Paying attention to linguistic input with some level of awareness.

**Writing-to-learn-language:** A classroom activity or approach using (usually not real-world) writing tasks as a way to teach or practice language.
